Dr. Allen Williams called the meeting to order at 6:35 p.m.

1. Introduction of Guest/Public Participation: None.

2. Setting the Agenda:

a) COVID-19 Data Update

Peter Lopatin provided an update on COVID-19 data for Winnebago County cases. He noted that the data reflects the recent increase in overall cases, school-related cases and the shifting demographics/geography in where the increases are being reported.

1) Approval of Finance Committee minutes - March 10, 2021

Dr. John Halversen entertained a motion to approve the March 10, 2021 Finance Committee minutes. James Powers made first motion; Dr. David Helland made second motion. Unanimously approved, motion carries.

2) Financial Statements

a) Resolution of Expenditures – February 2021

Dr. John Halversen asked for a motion to approve the health fund expenditure for February 2021. Luci Hoover moved and Dr. David Helland seconded to approve the health fund expenditure for the month of February 2021 for \$786,919.31. Unanimously approved, motion carries.

b) Statement of Fund Balance

Dr. John Halversen indicated that the Statement of Fund Balance beginning balance February 28, 2021 is \$10,733,400.43. Revenues YTD is \$3,814,445.82. Disbursements YTD is \$5,051,477.05. Ending balance is \$9,496.369.20. No irregularities were noted.

c) Financial Review

Dr. John Halversen indicated that this is 5th month of Winnebago County's Fiscal Year 2021 and it is the 8th month of the State of Illinois Fiscal Year 2021. Revenue YTD Budgeted \$5,993.117.60, Actual was \$3,814,445.82 with a variance of \$2,178,672. Expenses YTD Budgeted \$5,969,527.71, Actual & Encumbered was \$5,051,477.05 with a variance of \$918,051. No irregularities were noted.

d) Balance Sheet

James Keeler provided an overview of the February 2021 Balance Sheet. Assets for \$12,121,513.15, Liabilities is (\$2,625,143.95) and the fund balance of (\$9,496,369.20). No irregularities were noted.

f) Revenue and Expenditure Reports

Jim Keeler indicated that the overall financial picture of revenue and expenses are showing a very sizable deficit of almost \$1,250,000 but next month we will be recognizing our quarterly allotment of real estate taxes so that should cover half of the amount. Food Service permits are on hold. Once we get some of these issues resolved, we will get to an break even point for the whole year. No irregularities were noted.

g) Public Health Emergency Reserve Minimum Graph

The Public Health Emergency Reserve Minimum Graph was reviewed and the reserve amount is above the minimum established by the Board of Health.

h) Accounts Receivable

Accounts Receivable total due from Grantors is \$1,283,865.00. No irregularities were noted.

5) Permit Fee Reduction Proposal

Dr. Sandra Martell indicated that Winnebago County Board is proposing to waive Food Permit fees for this fiscal year for Category I food establishment, which is the high risk, dine in areas. Category I facilities have been financially impacted by COVID-19. Winnebago County will reimburse WCHD through host fees for an approximate total of \$250,000. WCHD Board of Health needs to recommend to the Winnebago County Board to amend the ordinance to waive the fee for this year

for Category I facilities. Ron Gottschalk made a motion to recommend to the Winnebago County Board to approve *Resolution To Waive 2021 Annual Food and Beverage Permit Fees for Category I Facilities* as amended. Seconded by Dr. David Helland. Unanimously approved. Motion carries.

7. NEW BUSINESS / OTHER MATTERS:

Dr. Sandra Martell provided the following Legislative updates:

House Bill 2804

Amends the Counties Code. Provides that no member of a county board or board of county commissioners, during the term of office for which he or she is elected, may be appointed or serve as a member of the board of health of that county. Effective immediately. Illinois HB2804 is sponsored by Representative Brad Halbrook.

Dr. Sandra Martell indicated the IPHA has their lobbyist to review and provide the rationale and how might we propose some amended language. Board of Health may want to consider this item at the next Policy Committee and possibly providing an opposition response to the resolution that is proposed.

Senate Bill 1721

Amends the Property Tax Code. In provisions about delinquent property, provides that a county may take steps necessary (currently, shall take all steps necessary) to acquire title to the property and may manage and operate the property, including, but not limited to, mowing of grass, removal of nuisance greenery, removal of garbage, waste, debris or other materials, or the demolition, repair or remediation of unsafe structures. Provides costs to be distributed to taxing districts, including operation and maintenance costs and all costs associated with county staff and overhead used to perform the duties of the trustees. Reduces the maximum penalty bids for the annual tax sale from 18% to 12%. In provisions about redemption of property, limits the assessments of penalties from every 6 months to 12 months. Makes conforming changes. Amends the Counties Code and Illinois Municipal Code. Modifies the requirements to have a circuit court declare property abandoned. Senate Bill 1721 is referred to Assignments and is sponsored by Senator Steve Stadelman.

Dr. Sandra Martell indicated that SB1721 is similar to a fast track and the Winnebago County Board will be reviewing and possibly an item the Board of Health may want to review.

Senate Bill 2278

Amends the Counties Code. Provides that a county that is authorized to impose a Special County Retailers' Occupation Tax For Public Safety, Public Facilities, Mental Health, Substance Abuse, or Transportation may establish a 7-member board, which shall oversee the use of funds received from the tax. SB2278 is referred to Assignments and is sponsored by Senator Steve Stadelman.

Dr. Sandra Martell indicated this tax referendum was passed last March 2020. WCHD worked through the resolution process to establish the Community Mental Health Board that was responsible for oversight of the funds. Resolution 2019 CR 128 Resolution Authorizing the Establishment of Winnebago County Community Mental Health Board was passed in October 2019 by Winnebago County Board. WCHD serves as the fiscal agent of the Winnebago County Mental Health Board. The Board of Health may want to consider further review at the next Policy Committee.
