Recommended Action in Response to Increase in Respiratory Viruses

January 2, 2026

Respiratory surveillance activity in the region is showing an increase in influenza like illness (ILI), COVID like illness (CLI) activity and confirmed influenza cases.

Based on the surveillance activity identified in the Week 52 Respiratory Report (see attached), the Winnebago County Health Department (WCHD) is recommending hospital inpatient and long-term care facilities (skilled nursing) in the Winnebago County implement enhanced Infection Control Practices for respiratory viruses to reduce the impact on the most vulnerable within the community. These practices include:

1. Temporary visitor restrictions for anyone under the age of 18; and
2. Universal masking within the facility.

The following summarizes influenza activity at the national, regional, state and local level.

U.S. – The [Centers for Disease Control and Prevention](https://www.cdc.gov/influenza/) (CDC) reports as of December 30, 2025, Seasonal influenza activity is elevated and continues to increase across the country.

Illinois – [The Illinois Department of Public Health](https://www.idph.illinois.gov/covid-19) is reporting moderate activity for the week ending December 20, 2025 (Week 51). The percent of outpatient visits for ILI was reported at 4.5% (baseline 2.3%).

Local (Winnebago County) – ILI reported from sentinel sites through BioSense Syndromic Surveillance System increased to 5.77% (baseline 2.3%) of emergency department (ED) visits for Week 52. Reported laboratory conformed cases of influenza increased 173% from Week 50 to 51 and a 41% increase between Week 51 and 52. Week 52 saw the single largest number of cases reported this influenza season.




CDC Week 52: Week Ending Saturday, December 27, 2025

COVID-19, Influenza, and RSV vaccinations are recommended to prevent severe respiratory illness.

Weekly Influenza Activity Summary: This week's surveillance activities shows **761** cases of influenza in Winnebago County as detailed in this report. Influenza surveillance for the County involves the weekly collection of data from our partners including hospitals, physicians, clinics, long term care (LTC) facilities and laboratories.




↑ The above graph illustrates the total number of flu cases reported during the current influenza surveillance period. The four year historical average for the County is noted by the orange line on the graph.

ICU Admissions by Respiratory Illness


Respiratory virus associated Intensive Care Unit (ICU) Admissions:

The total number of ICU admissions by respiratory illness reported during the current respiratory surveillance period.




LTC Facility Outbreaks and ED Illness Surveillance

Respiratory Virus Outbreak Activity in Long Term Care Facilities: The Health Department uses surveillance data to monitor respiratory outbreaks in long term care facilities as part of the community's current activity with respiratory viruses. An outbreak is defined as three or more cases of a specific virus occurring within 72 hours of each other.

Percent of emergency department visits attributed to respiratory illness for residents of Winnebago County.




Practice and promote the three C's in helping prevent the spread of respiratory viruses in our community:


CLEAN - Wash your hands
